N. Rani aged about 43 years, resident of Khumujamba
Churachandpur beg to submit the following few lines
for your kind consideration and necessary action.

That on 03/05/2023 at about 7:00pm some
unknown person's numbering about 1700 belonging to
Kuki community started attacking the undersigned along
with family members. Thereafter, the Kuki people
started destroying and burning the house of the
undersigned resulting in all the properties of the under-
signed were ranged to the ground and all the belongings
and jewellery were also burned / destroyed / stolen
before burning the house.

A separate sheet showing the particulars of all the
losses incurred by me is attached along with the
Present application.

In the above facts and circumstances, it is
therefore respectfully request that your goodness may
cause the arrest of the miscreants who belongs to
the Kuki community involved in the burning and
damaging my properties and take up an FIR

against them as soon as possible for the
interest of justice,

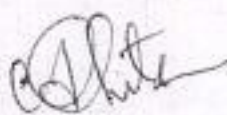

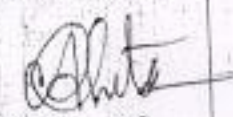
