P.O.

(I could not remember my vehicle registration number/under process for registration) and household properties, valuable documents and thereby amounting to a sum of Rs.1,02,36,00(Rupees Charles and Charles and Manipur With Manipur with approximately altogether.

I could not report in timely to the concerned police station due to the prevailing situation and myself with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur.

In this regard, you are, therefore, requested to take legal actions against the persons who acted illegally and punish them under the eye of law as soon as possible.
