Sir,

As per verbal instruction from SP-CCP regarding unlawful activities like demolition of building occurring in Meitei areas. I personally went to Khumujamba to confirm the fact and ascertain the activities happening in that area. On reaching the spot, the locality have turned into an open space, all the abandoned structures, establishment, and building of the Meitei community which were vandalized and once still standing have completely been destroyed, razed to the ground and turned into rubbles. It is highly suspected that the unlawful activities in the said areas were mainly carried out by youths from the nearby locality, some unknown drugs abusers who were searching for scraps and dismantling the structure and unknown ITLF volunteers and members over a period of time. The unlawful activities have started since the outbreak of the communal clashes starting from 3/5/2023 and 4/5/2023 onward as the Meitei community have abandoned their houses/properties and fled for safety. All properties and valuable items were either stolen away or burnt down. It is also found out that these unlawful activities were carried out early in the morning or late at night when public eyewitnesses and security force are minimal.
