I, the undersigned have the honour to state that I have been staying at my parental house with my sons since about 2 months. On 10/11/2023, my son namely Miraj (6) yrs have taken by the family member of my husband at their house. Then on 12/11/2023 at about 1:00 pm, I went to the house of my in-laws located at Phundrei Awang Leikai to take my son Md. Miraj (6) yrs, I was seriously beaten up by my father-in-law namely Md. Iboyai (55) yrs S/o (L) Md. Seradin of Phundrei Awang Leikai and my mother-in-law namely Mrs. Khatamjan (50) yrs W/o Md. Iboyai of -do- along with their son namely Md. Washim (25) yrs S/o Md. Iboyai of -do- without any reason. As a result, I received injury on my body and medically treated at District- Hospital Thoubal, Khangabok. I could not report the matter in time due to medical treatment.

It is therefore requested to kindly take up the necessary legal action against the said accused persons as per law.
