1. That, I and my family members are victims of the
Present unrest that occurred from 03-05-2023 onwards.
2. That on 03/05/2023 at around 730 P.m. while I was at my
residence situated at Fouving Khuga tampax, P.O. P.S.
Churachandpur Dist. Manipur along with my family
members consisting of myself, my husband/wife, children
and other family members, some unknown armed
miscreants attacked my house, physically assaulted my
family members including myself and destroyed
household properties worth around ₹ 3756700 Rupees
Thirty Seven lakh fifty six thousand Seven hundred only
approximately.

In view of the facts and circumstances, I shall be very
great full if your good self would kindly initiate
appropriate steps for indentifying the unknown arms
miscreants apprehend them and Punish them in
accordance with law.

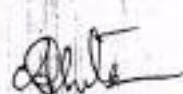
