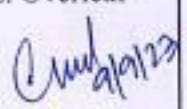
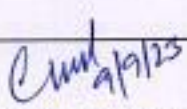

Respected Sir,

1. The undersigned beg to report for your kind consideration necessary action.

1. That, I and my family members are victims of the present Under that occurred from 03-05-2023 onwards.
2. That on, 03-05-2023 at around 7:00 am/p.m., while I was at Cpu. Thingkaupha along with my family members consisting of my my husband/wife, children and other family members, some Unknown armed miscreants attacked my house, physically assault my family members including myself and destroyed household properties worth of Rs 5,25,000 (Rupees: Five Lakh Twenty Five Thousand.) approximately.
3. That, the unknown miscreants are suspected to be of the Ri tribe as they conversed among themselves in the Ruki dialect in physically assaulting my family and destroying my household properties. The said Unknown armed miscreants also set on fire and burned down my residential house, private vehicle and other household items which are given in the list enclosed along with this report.
4. That, the Unknown armed miscreant warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing F.I.R. is due to displacement, and Uncertainty of relief Camp/Place.

View of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law.
