A separate sheet showing the particulars of all the losses incurred by me is attached along with the persent application.

In the above facts and circumstances, it is therefore respectfully request that your goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/damaging my properties and take up an FIR against them as soon as possible for the interest of justice.
