With due respect, I the undersigned namely Laipekakram Gandhi  
aged about 39 years, resident of Khumijamba, Churachandpur  
beg to submit the following few lines for your kind consideration and necessary  
action.

That on 4/05/2023 at about 10:00 am some unknown persons  
numbering about 1000 belonging to kuki community started attacking the  
undersigned along with family members. Thereafter, the Kuki people started  
destroying and burning the house of the undersigned resulting in all the properties  
of the undersigned were razed to the ground and all the belongings and jewelleryes  
were also burned/destroyed/stolen before burning/damage.

A separate sheet showing the particulars of all the losses incurred by me is  
attached along with the persent application.

In the above facts and circumstances, it is therefore respectfully request that  
your goodself may cause the arrest of the miscreants who belongs to the Kuki  
community involved in the burning/dismantling/damaging my properties and take  
up an FIR against them as soon as possible for the interest of justice.


