I, the undersigned beg to report for your kind and necessary action.

- That, I and my family members are victims of the present unrest that occurred from 03-05-3-2023
 onwards.
- 2. That, on 3rd may at around 9:00 P.M., while I was at home along with my family members consisting of myself, my husband/wife, children and other family members some unknown kuki armed miscreants attacked my house, physical assaulted my family members including myself and destroyed household properties worth around Rs. 13,45,000 (Rupees Thirteen Lakhs fourty five Thousands) approximately.
- 3. That, the unknown miscreants are Kuki tribe as they conversed among themselves in the Kuki dialect while firing and physical assaulting my family and destroying my household properties. The said unknown are miscreants also set on fire and burned down my residential house, jewelries, kitchen and electronic, cloths, ration items and money in cash private vehicle and other household items which are given in the list enclosed along with this report.
- 4. That, the unknown miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filing a FJ.R is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very gratefully if your good self would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with view.
