Respected Sir,

I, the undersigned beg to report for your kind and necessary action.

1. That, I and my family members are victims of the present unrest that occurred from 03-05-2023 onwards.

2. That, on ... 03/05/2023 ... at around 7:30 a.m./p.m., while I was at my residence situated at Tuibong Morjen Bank,

P.O. Tuibong P.S. Tuibong DIST Chura Champur Manipur, along with my family members consisting of myself, my husband/wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs. 364,000/- (Rupees Three Lakh Sixty four Thousand...) approximately.

3. That the unknown miscreants are suspected to be the kuki tribe as they conversed among themselves in the kuki dialect while firing and assaulting my family and destroying my household properties. The list of family members and damaged properties are enclosed with this report.

4. That, the unknown armed miscreants warned and threatened my family members and myself to leave the village permanently and that we will face dire consequences if we return to our village again. Delay of filling a F.I.R is due to displacement and uncertainty of relief camp/place.

In view of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish them in accordance with law. Re-treated as an O.E. of case




