1. I am a permanent/temporarily resident of Khumiamba Meitei  
Leikai, Churachandpur since/last 22 years/born. The unknown  
Kuki Tribes/Militants destroyed, looted and also set fire and burned down my own/rented

of \_\_\_\_\_ (2 Gorse Sathang).

2. They also looted and fired my own/rented Grocery/Shop at Khumiamba  
Meitei Leikai, Churachandpur owner of Shri Moirangthem  
Boyai Singh of Khumiamba Meitei Leikai, upur.

3. Presently, I displaced and staying at the relief camp at Thanga Chingkhia Leikai  
Mandop Joint Organized by Arica Club, Meira Paibi & Local Organisation.

I also therefore request you to kindly take up necessary legal action. Delaying of  
filling report is due to displacement and uncertainty of relief camp. Still we/I stand at the  
door of law.


