Dear Sir/Madam,

With due respect, I, the undersigned beg to say that I am a permanent/ Temporarily resident of Khugatampak Meikei Likai ^{Zensang Lamka} but now displaced and staying at the relief camp at Thanga Chingha Arica club Relief camp. I further beg to inform you that my house at Khugatampak Meikei Likai ^{CPN} has been burnt down by gun toting Kuki whom I believe to be Kuki Militants who are under Suspension of Operation (SoO) and my properties worth 3.0 Crores of rupees have been looted by the Kuki. I therefore request you to kindly take up necessary legal action against these criminals and restore my properties to me.

And for this act of kindness, I shall remain ever grateful to you.




