house at Khugatampak Meitli Leikai <sup>cepur</sup> has been burnt down by gun toting Kuki whom I  
believe to be Kuki Militants who are under Suspension of Operation (SoO) and my properties worth  
1.5 Crores of rupees have been looted by the Kuki. I therefore request you to kindly  
take up necessary legal action against these criminals and restore my properties to me. On 3/5/2023  
at 6:30 PM.

And for this act of kindness, I shall remain ever grateful to you.




