With due respect, I, the undersigned beg to say that I am a permanent/ Temporarily resident of Churachandpur Nghathal but now displaced and staying at the relief camp at Thanga part I Gram panchayat under Arica Club. I further beg to inform you that my house at C.C. pur Nghathal Meitei Leik has been burnt down by gun toting Kuki whom I believe to be Kuki Militants who are under Suspension of Operation (SoO) and my properties worth ₹ 5,00,000 of rupees have been looted by the Kuki. I therefore request you to kindly take up necessary legal action against these criminals and restore my properties to me. on 8/5/2023 at 6:30 PM.

And for this act of kindness, I shall remain ever grateful to you.




