We, the undersigned would like to report that on
03/05/2023 at around 10:00 pm, some unknown persons
numbering about 100 persons belonging to Kuki community
started attacking the villagers of Khuga Tampak. Thereafter,
the Kuki people started destroying and burning (Arson)
the villagers houses resulting in burning the office of
"Apumba Lup Meira Paipi" located at Khuga Tampak,
Churachandpur. In the above Arson we have loss
the followings items:- i) One Pukka house ii) Two Almira
iii) Two Tables iv) 20 Plastic chairs v) One Sofa Set.
The total approximate value of lost property is around
Rs. 20,00,000/- (Twenty lakhs)

In the above facts and circumstance, we therefore
respectfully request to your Office to cause the arrest of
the miscreants who belongs to the Kuki community
involved in the Arson for the interest of Justice.

It is therefore, we requested you to kindly take
up necessary legal action against the accused persons.

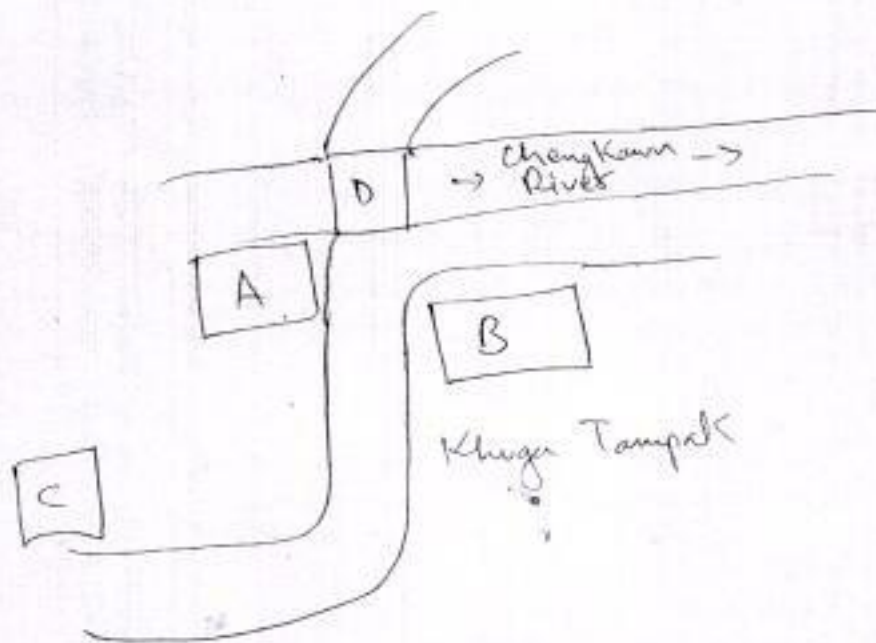
