

Madam,

With due respect, I have the honour to report you that on 16/11/2023, I went to my parental house at Lilong Haoreibi Turel Ahanbi Salam for participating marriage ceremony of my relatives. After participating the said marriage ceremony, on 21/11/2023 at around 8:00 pm I was brought by my mother at my matrimonial home. On that day, there was a hot exchange of words between my husband namely Md. Amir @ Anis Khan and my mother. After my mother left from the house, on the same day at around 12:00 midnight, when I was sleeping with my son aged about 5 yrs on my bed, my husband awake me and pushed me from the bed and he seriously beaten up me inside my bed room and also threaten me to take out my cloths. Due to his violent act I sustained injuries on my forehead and many parts of my body. I shouted for help but nobody came inside my room. The above name my husband tried to driven me from his house. On 22/11/2023 at around 4:00 am, he forcibly took me on his four wheeler vehicle Alto car, gold in colour and drop me at near the entrance gate of parental home. He went out from there by leaving me behind. My husband started tortured and harassed me physically and mentally since 1 yrs back. I was medically treated at the clinic of Dr. Basir located at Lilong Bazar on 22/11/2023 and later on 25/11/2023 at RIMS, Imphal. While discussing for an amicable settlement between my husband and me, the report can't be submitted in time.

It is therefore requested to kindly take up the necessary legal action against the said persons as per law.

This report is written as narrated by me.
