Subject: First Information report against Mr. Sobha, Mr. Sanathoi, Mr. Boicha and some unknown Meitei militants.

Sir,

I was a mere worker at Sobha Farm since March, 2023 earning just Rs. 3000/- per month. Unfortunately, on 19<sup>th</sup> November, 2023 at around 12:00 noon while I was praying lonely in my staying farm house I was suddenly pickup by Mr. Sobha, Mr. Sanathoi, Mr. Boicha and some unknown Meitei militants with sophisticated wapons. This incident took place at Sobha Farm, Heirok Part - II, Thokchom Leikai of Thoubal District and all of the accused persons are from the above locality.

At around 1:00pm both my hands and legs were tied up with a rope and started hitting on my face and my whole body. I was mercilessly beaten blue and tortured (3<sup>rd</sup> degree) since when I was picked up until I hardly escaped.

I was kept to be killed on 26<sup>th</sup> Nov. 2023 (as I heard from their conversation), but luckily I could hardly escape from their hand and reached Tengnoupal on foot. While I was in their custody, I enquired to some persons why am I being treated inhumanely. I was accused as informer to Kuki's so I am being tortured and kept to be killed only because of my mother belongs to Kuki's.

I therefore, would like to request you to kindly register an FIR and take necessary action against Mr. Sobha and those militants involved in the said incident.
