I the undersigned beg to report for your kind necessary action.

1. I and my family members are victims of the present unrest that occurred from 03/05/2023 onward.
2. That, on 04/05/2023 at around 8:00 p.m. while I was at my residence, Tuibong Zion Veng P.O./P.S. Chapur, Churachandpur District, P.O./P.S. Churachandpur along with my family members, some unknown arm miscreants attacked my house, physically assaulted my family members including myself and destroyed my house, physically assaulted my family members and destroyed household properties worth around Rs. Thirty six lakhs and eighty six thousands approximately. The said unknown armed miscreants also set on fire and burned down my residential house and other household items which are given in the list enclosed along with this report.

In view of the facts and circumstances, I shall be very grateful if your good self would kindly initiate appropriate steps for identifying the unknown arm miscreants, apprehend them and punish them in accordance with law.


