With due respect, I the undersigned namely Lairenmayum Ranjan S
age about 28 yrs. resident of Moirang Khunou Awang leikai beg to
submit the following few lines for your kind consideration and
necessary action.

That on 3rd May 2023 at about 7 PM some unknown person
numbering about 200 belongs to Kuki community. started attacking
and destroying and burning / stolen before burning. all the belonging
jewelries from my shop at old bazar Super market ccpur and
from my rent which is at new bazar opposite to Punjab National
bank ccpur. My shop was facing south. on my left. Prem shop.
on my right Indira shop. In front of me a house of a family member
of old bazar security.

In the said incident was badly injured due to pelting of stones /
hacking with knife / shot from firearms toward us by the miscreants.
A separate sheet showing the particulars of all the losses incurred to
me is attached along with the present application.

In the above fact and circumstances, it is therefore respectfully
requested that your good self cause the arrest of the miscreants
who belongs to the Kuki community involved in the burning / dismantling
damaging my properties and injuring and take up a FIR against
them as soon as possible of the interest of justice.

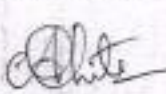
