Subject: Report

As per endorsed, I conducted an inquiry regarding the abduction of 2 Meitei-Muslim from Teddim road near JP Selection by searching suspected places to rescue to abducted person along with a team of CCP-PS led by OC-CCP-PS. As per reliable source, search continued in places like Vajing area and Ebenezer area. However, no arrest or rescue of the abducted person could be made. On further search, the individual was rescued from the outskirts of Canan veng, New Lamka. He was later identified as M Shabbir Ahamad S/o M Sayeed Ahamad of Mana Luugkhoh, Hatta, Imphal East.

From his statement it is known that he is an active service in Manipur Police Department with a rank of Sub-Inspector. He was presently posted at CDO-IE. He stated that on 9/9/2023, he and his other friends were visiting CCpur to meet his friend Papau Kuki (driver of Shri Letkhogin, IAS). When he reaches Lamka, he witnessed a crowd gathering and singing front of CCP-PS. Out of curiosity and excitement, he parked his car near the roadside and started recording videos and pictures of the gathering. In that, by stander saw the flag of Salai Taret which was pasted on his car and raised concerned over it. Thus, they automatically detained him while his other friends managed to escaped. He was abducted from Teddim road, put in different car and taken to an undisclosed location. He was pulled out of the car and the abductors started interrogating him. He also received bruise on his person as a result of assault by the abductors. He was further interrogated and asked whether he belongs to members of Arambai Tengol or not. He replied and told them that he is a Sub-Inspector in Manipur Police and had no connection with them. He also disclosed in his statement that he could see a letter CVDF written on the T-Shirt of his abductors and he also seen some of them carrying arms. After thorough search, he was rescued by a police team of CCP-PS and later kept at the safe custody of Churachandpur police station.
