Sir,

I have the honour to state that in the recent communal issue happened in the state,

we were forcibly compelled to displace from a rent located at Beulaland, Churachndpur where we have been staying for three months or so leased by a local.

In the said incident, all our household items from electrical cum electronic items to kitchen items approximately worth about Rs. 5.4 lakhs were stolen, destroyed from the rent and School uniforms, books and educational related documents belonging to my son namely Huiem Paikhomba Singh, 13 yrs reading in class VIII at the Path way School, Rengkai were burnt down by some armed persons from Kuki community numbering about 20/30 persons on 03/05/2023 at about 6.10 pm. So, we left the place the next day i.e. on 04/05/2023 at about 9.20 am for our lives and presently taking shelter at a house of my relative at Moirang Maibram Leikai.

It is, therefore, requested to kindly register a case against those perpetrators under the suitable sections of law.


