aged about 57 years, resident of Light House Lane, Zehang Lamka  
beg to submit the following few lines for your kind consideration and necessary action.

That on 3<sup>rd</sup> May 2023 at about 6.30 PM, some unknown persons number  
about 100, belonging to Kuki community started attacking the undersigned along with far  
members. Thereafter, the Kuki people started destroying and burning the house of  
undersigned resulting in all the properties of the undersigned were razed to the ground and all  
belongings and jewelries were also burned/destroyed / stolen before burning/ damage.

In the said incident \_\_\_\_\_ was badly injured due to pelting  
stones/hacking with knife/shot from firearms toward us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along  
with the present application.

In the above facts and circumstances, it is therefore respectfully requested that you  
goodself may cause the arrest of the miscreants who belongs to the Kuki community involved  
the burning/dismantling/ damaging my properties and injuring \_\_\_\_\_ and take  
an FIR against them as soon as possible for the interest of justice.
