Subject: Report on losses in the recent communal clash and to take up an FIR.

Sir,

With due respect, I, the undersigned namely Laishom Robin Singh S/o Laishom Goudhon Singh, aged about 32 years, resident of Khumujamba Meitei Leikai, Churachandpur beg to submit the following few lines for your kind consideration and necessary action.

That on 3rd May, 2023, at about 6:30 p.m., some unknown armed persons numbering about 100 belonging to Kuki community started attacking the undersigned along with family members. Thereafter, the Kuki people started looting and destroying my rented residence resulting in all the properties and belongings of the undersigned including jewelries were destroyed and stolen before burning.

We were rescued by Armed Security Personal and provided shelter at a safe place in Churachandpur for the first few days.

Later on, we have been evacuated to Relief Camp within Bishnupur District under armed escort. Hence, I was not able to report regarding this matter to the police on time. We are still in the Relief camp at the time of filing this application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/ damaging my properties and take up an FIR against them as soon as possible for the interest of justice.
