 That I and my family members are victims of the present unrest that occurred from 03-05-2023. onwards.

2. That on 3nd May at around 7:30 a.m./p.m., while I was at my residence located at New Bazda po Churchardpur ps Churchardpur Dist Churachard Day , Manipur along with my family members consisting of myself my husband/wife, children and other family members, some unknown armed miscreants attacked my house, physically assaulted my family members including myself and destroyed household properties worth around Rs 20, 00, 000/ (Rupees Twenty Lotth, approximately.

3. That, the unknown miscreants are suspected to be of the Kuki tribe as they conversed among themselves in the Kuki dialect while firing and physically assaulting my family and destroying my howehold properties. The said unknown armed miscreants also set on fire and burned down ma residential house vehicle and other household items which are given in the list enclosed along with this report

That, the unknown armed miscreants warned and threatened my family members and myself to leade the village permanently and that we will face dire consequences if we return to our village again. Delay of filling F.I.R is due to displacement and uncertainty of relief camp/place. In view of the facts and circumstances. I shall be very grateful if your goodself would kindly initiate appropriate steps for identifying the unknown arms miscreants, apprehend them and punish thein in accordance with law.
