Sir,  
With due respect, I the undersigned namely Leishangthem Pamenjit (40) 3/0(L) L. Bomcha Singh of D. Phakten Maitei Leikai Churachandpur beg to submit the following facts for your kind consideration and necessary action.  
That on 3rd May 2023, at about 07:00pm some unknown persons numbering about 20s belonging to Kuki Community started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the house resulting in all the properties were razed to the ground and all the belongings and jewellery are also burnt and damaged. Approximately Rs. 10,000/- of my belongings were lost/damaged at the said incident.

In the above facts and circumstances, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to Kuki Community involved in burning/dismantling/damaging my properties and take FIR against them as soon as possible for the interest of justice.


