Today i.e. 23/04/2023 at 9:10 pm received a reliable information that on the same day at around 9:05 pm, one Hyundai i-20 car bearing Regd. No. MN09A-0321 driven by one unknown driver which was proceeding from Imphal side towards Bishnupur side collided with one Honda Activa bearing regd.
