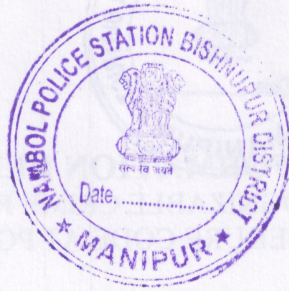

Today i.e. 23/04/2023 at 9:10 pm received a reliable information that on the same day at around 9:05 pm, one Hyundai i-20 car bearing Regd. No. MN09A-0321 driven by one unknown driver which was proceeding from Imphal side towards Bishnupur side collided with one Honda Activa bearing regd. No. MN06SE-1765 ridden by one unknown rider, triple seated which was proceeding in the opposite direction at Nambol Thongkha along Tiddim road due to rash and negligent driving on the part of both the unknown drivers of the vehicles. As a result of which, one unknown pillion rider of the said Honda Activa succumbed on the way to hospital and the unknown rider and pillion rider of the Honda Activa sustained injuries on their persons and evacuated to hospital for their medical treatment. Both the involved vehicles were also badly damaged.

Hence, a regular case under FIR No. 24(04)2023 NBL-PS U/S 279/338/427/304-A IPC is registered on suo moto for investigation.
