Subject : Report on losses in the recent communal clash and to take up an FIR.

Sir,

With due respect, I, the undersigned namely Nongthombam Bomi
S/o Late N. Ibopistak aged about 43 years, resident
of Khumijam Bz Meitei beg to submit the following few lines for your
kind consideration and necessary action.

That on 03 May, 2023, at about 6:30 pm some unknown armed persons
numbering about 100+ belonging to Kuki community started attacking the undersigned
along with family members. Thereafter, the Kuki people started destroying and burning the
houses of the undersigned resulting in all the properties of the undersigned were razed to the
ground and all the belongings and jewellerys were also burned, destroyed, stolen before
burning and damage.

In the said incident I, was badly injured due to petting of
stones and hacking with knife and shot from firing toward us by the miscreants.

Hence, I was not able to report regarding this matter to the police on time. We are still in the
Relief camp at the time of filling this application.

In the above facts and circumstances, it is therefore respectfully requested that your
good self may cause the arrest of the miscreants who belongs to the Kuki community involved
in the burning, dismantling and damaging my properties and injuring and take up
an FIR against them as soon as possible for the interest of justice.


