Sir.

With due respect, I, the undersigned namely Konthouyam Buranget Meiter W/o Konthouyam Busa Mercer aged about 34 years, resident of Thing Kang phai churach and pus beg to submit the following few lines for your kind consideration and necessary action.

That on 3rd May, 2023, at about 7.30/h some unknown armed persons numbering about 1000....belonging to Kuki communuty started attacking the undersigned along with family members. Thereafter, the Kuki people started destroying and burning the houses of the undersigned resulting in all the properties of the undersigned were razed to the ground and all the belongings and jewelleries were also burned, destroyed, stolen before burning and demage.

In the said incident, was badly injured due to petting of stones and hacking with knife and shot from firearing toward us by the miscreants.

Hance, I was not able to report regarding this matter to the police on time. We are still in the Relief camp at the time of filling this application.

In the above facts and circumstances, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to the Kuki community my properties and and demaging burning, dismantling involved in the injuring and take up an FIR against them as soon as possible for the interest Retreated at an O.K. of case of justice.
