Subject: Report regarding theft of a vehicle from my house

Sir,

I have the honour to state that I am a resident of Khumujamba Meitei Leikai, Churachandpur for the last 20 years or so. In the recent incident of communal tension between Meitei and Kuki, we were compelled to leave the place as violent activities like destruction and burning of houses started to happen at the areas where we were residing. As such, my family left the place on the 4<sup>th</sup> May, 2023 at about 11.00 am for saving our lives and presently taking shelter at Moirang Thangjing Guest House Relief Camp.

In the incident, my house and other properties were completely destroyed by some persons from Kuki community on the 3<sup>rd</sup> May, 2023 at about 06.30 pm in which one two wheeler vehicle MAESTRO EDGE bearing Regn. No. MN01AM 2892 standing in my name was also stolen from my house along with the relevant documents of the vehicle by some perpetrators who belonged to Kuki community.

It is, therefore, requested to kindly initiate a legal action against those perpetrators and help me find the stolen vehicle please.
