With due respect, I would like to state that, I am
working in Jawahar Nave Daya Vidyalaya, Churachandpur
as of Supdt. and staying Type III Str NO. 4 inside the campus.
That Sir, due to recent communal riot/clash between 2 com-
munities, my vehicle i.e. sports car (Chamfange Gold color)
bearing NO. MN06LB2236 was self stranded inside the
Vidyalaya campus along with 2 keys (Key are inside the Str).
That I was also displaced and stranded and taking
shelter inside the 36 Assam Rifles, Churachandpur from the
midnight of 03/05/2023. Later it is learnt and confirmed
from local staff that the said vehicle was taken away
(Keys collected from the Str by breaking door) by the
unknown miscreants forcibly on 07.05.2023 at around
5:30 pm. The value of the vehicle is 2.60 Lacs (approx).
I could not report well in time due to the present
law and order situation prevailing in the State as well as
self was displaced and stranded.

In view of the fact and circumstances, I shall be
very grateful, if your goodself would kindly take up
necessarry action against them to retrieve the said
vehicle.

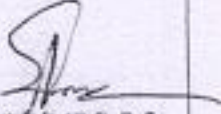
