Sir.

I am to report that today i.e. 3rd May, 2023 at 1:00pm received a reliable information that on the same day at around 12:45 pm 23 (twenty three) numbers of students(male and female) from "Spirit of Faith" Bible School, Dimapur including one lady from Myanmar were detained at Khajiri Maning Leikai area by the localities. Accordingly, I along with my police team including lady constable rushed to the said area and found all the detainees along with the suspected Myanmarese lady. On spot verification, she identified herself as one Nan Daewee aged about 20 years D/o Mat KyinLay Shi, Sagaing, Myanmar (Burma)and could not be communicated in Manipuri, Bengali, Hindi, Assamese except English and some Tangkhul dialect. Moreover, she was unable to produce any valid foreign passport/ documents. However, she produced one Identity card of Spirit of Faith Bible School, 2023 under Roll No. 30 &DORM No. 05and one Aadhar Card having Aadhar No. 412573052561which stand in the name of Nan Daewee (D.O.B: 05/02/2003)C/o Mat Kyin Khriezephe village, Dimapur, Nagaland-797103. She further disclosed that she is a Myanmarese citizen who stayed at a border village between India and Myanmar (Jessami side) and came to India by crossing Nagaland border illegally and stayed at Dimapur pursuing bible theological studies at Spirit of Faith "Bible School" since two years back. As she had entered the Indian Territory without any valid documents from the concerned department, accordingly she has been apprehended and seized her personal belongings from the spot by observing necessary formalities at 2:00 pm of today i.e. 03/05/2023. The apprehended person along with the seized items are handed over to you for taking further necessary legal action against the illegal immigrant.
