Today i.e. 03/05/2023 at 11:15Pm received a reliable information that on the same day at around 11:10 Pm, an unruly mob numbering about 150/200 consisting of womenfolk stormed at the Meetei Evangelical Baptist Convention Church, Nambol Phojing Makha pelted stones and thereby caused badly damaged to some items viz. doors, windows, benches, main gate of the said church etc. However, no human injury was reported. The approximate value of the said damaged properties is Rs. 1, 00,000/- (one lac).
