Subject :- Report.

Sir,

I have the honour to report that today i.e. 19/11/2023 at around 04:00 AM received a reliable information that some unknown armed miscreants have hidden some arms, ammunitions and explosive at Gwarok Reserve Hill Range South East of Pechi for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Lilong, COB Thoubal 33 AR led by OC/CDO-TBL under the supervision of SP/TBL have rushed to the spot immediately and launched a massive operation at 04:30 AM by using metal detectors. On searching and found the under noted articles i.e. (1) 1 (one) No. of Factory made Pistol with 1(one) empty magazine, (2) 1 (one) No. of Country made Gun with 1(one) empty magazine, (3) 5 (five) Nos. of 36 Hand Grenades without detonator, (4) 2 (two) Nos. of Smoke Grenades marked as (WP) GREN No. 80 MK 1, (5) 9 mm – 07 (seven) nos. of rounds, (6) 5.56 mm – 03 (three) Nos. of rounds, (7) 7.62 mm x 39 mm – 03 (three) Nos. of rounds and (8) 7.62 x 51 mm – 12 (twelve) Nos. of rounds from the spot i.e. Gwarok Reserve Hill Range South East of Pechi at 06:10 AM.

Further, seized the aforesaid articles at 06:30 AM by observing necessary formalities.

It is, therefore, handed over the seized articles to you for taking further necessary action.
