Today i.e. 06/05/2023 at 11:00 am received a reliable information that on 05/05/2023 at around 9:05 am an unruly mob numbering about 100/150 consisting of womenfolk stormed at the Baptist Church located at Keiren Kabui Khul, Leimapokpam and pelted stones thereby caused badly damaged to some items viz. doors, windows, benches, desk etc. However, no human injury was reported.
