Today i.e. 20/07/2023 at 12:30 pm received an information that on the same day at about 11:40 am a public meeting was organised by Manipur Awang Chingkhei kanba Lup and Meira Paibee Lups at Khabeisoi, YOSC ground. The said meeting was attend by about 4,000(four thousand) women volunteers and 300(three hundred) male volunteers. The Topic of the meeting was "joint peaceful sit in protest against the demand for separate administration in Manipur cum public meeting for restoration of peace in Manipur". During the meeting one of the speaker namely Y. Premananda Professor of Manipur University Law Dept. gave a hate speech against the Kuki communities and encouraged the Meitei and Muslim community openly to take up arms and to kill the Kuki community with the intension to conspire any offences against the law of the land. And also encourage the public to attack the house of MLAs and ministers of Manipur at any favourable moment and also to burn down Manipur Assembly. Further, he insulted the Manipur police as incompetent and does nothing to safeguard the people as such his speech demoralise the Police who are working for 24hrs to safe guard the people of the State. So, Mr. Y. Premananda is liable for his hateful speech and insulting the devoted Manipur police in public place.

Hence, a suo-mottu case under FIR No. 33(7)2023 LLI-PS U/S 121(A)/153(A)/505(2) IPC has been registered for investigation.
