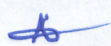

Today i.e. 06/05/2023 at 11:10 am received a reliable information that on 05/05/2023 at around 9:30 am an unruly mob numbering about 100/150 consisting of womenfolk stormed at the Keiren Presbyterian Church located at Keiren Kabui Khul, Leimapokpam and vandalized the properties as well as set on fire. As a result of which, most portions of the said church were gutted down. However, no human injury was reported. The approximate value of the damaged properties is Rs. 2(two) lacs.
