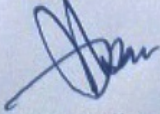

Respected Sir,

I have the honour to state that, on fateful day of 3rd May, 2023, at around 08:00 PM, more than thousand of miscreant suspected to be Meitei Youth of Arambai Tenggol, and others Meitei organisation carrying sophisticated weapons forcefully entered my village N. Heikon, P.O. Lamlong, P.S Lamalai, Island Sub-division, Kangpokpi District, Manipur having 39 houses including mine, after looting all the valuable items, burnt down all the houses and standing properties worth crores of ruppees into ashes.

This includes 1) Community Hall 2) Primary School 3) School Toilet & Kitchen 4) Angawadi Centre 5) Public waiting shed total value of approximately 1,80,00000/- (One Crore Eighty Lakhs) Rupees were also burnt into dust.

And Church properties i.e Church, Tables, chairs, Benches, Pulpit, Long Benches, Ceiling fan, Sound system, wiring, almiriah, Church kitchen, Store room, guest house etc. worth approximately 1,00,20,000/- (One Crore and Twenty thousands) were also burnt down.

I therefore request to booked the culprit and take necessary action as per the law of the land.
