I have the honour to state that, on fateful day of 3rd May, 2023, at around 08:00 PM, more than thousand of miscreant suspected to be Meitei Youth of Arambai Tenggol, and others Meitei organisation carrying sophisticated weapons forcefully entered my village N. Heikon, P.O. Lamlong, P.S Lamlai, Island Subdivision, Kangpokpi District, Manipur having 39 houses including mine, after looting all the valuable items, burnt down all the houses and standing properties worth crores of ruppes into ashes.

This includes 1) Community Hall 2) Primary School 3) School Toilet & Kitchen 4) Angawadi Centre 5) Public waiting shed total value of approximately 1,80,00000/- (One Crore Eighty Lakhs) Rupees were also burnt into dust.
