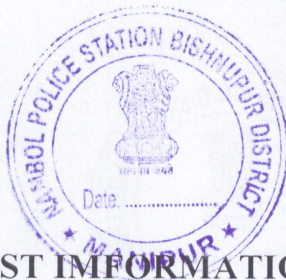

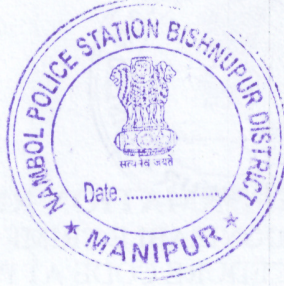

Sir,

With due regards and humble submission, I the undersigned have the honour to report that on 04/05/2023 at around 9:45 pm an unruly mob numbering about 200/250 consisting of womenfolk stormed at the "Landmark Missionary Baptist Church located at Nambol Phoijing Makha" and vandalized the properties as well as set on fire. As a result of which, most portions of the said church were gutted down. However, no human injury was found during the incident. The approximate value of the damaged properties is Rs. 5,00,000/- (rupees five lakhs).

It is, therefore requested, to kindly take up necessary legal action against the culprits at the earliest.
