Sir,

On the 3rd of May, 2023 night at around 9-10 PM, large number of youths suspected to be 'Arambai Tenggol', group from Meitei community carried gun, ammunitions and other deadly weapons attack our village; N. Terakhang under Lamlai Police Station, Kangpokpi District, Manipur. All the houses, Church and school were totally burnt down. I and my family fled to save ourself through Jungles for 3 days and night till we reach safe zone.

My house and properties were totally burnt down. Estimated value of my house and properties burnt down would be 25 - 30 Lakhs (approximately).

I therefore request you to book the culprit and take necessary action.
