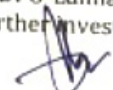

I have the honour to state that, on 3rd May, 2023, 08:00 PM more than thousand of miscreant suspected to be Meitei Youth of Arambai Tenggol, and others Meitei organisation carrying sophisticated weapons forcefully entered my village N. Heikon, P.O. Lamlong, P.S Lamlai, Island Sub-division, Kangpokpi District, Manipur having 39 houses including mine, after looting all the valuable items, burnt down the remaining into ashes leaving us homeless. Apart from our houses, all of our documents/certificates were also burnt to ashes.

I therefore request to booked the culprit and take necessary action as per the law of the land.
