I am writing this Complain letter to bring to the notice of the concerned authority in connection to the Brutal Killing of Mr. Tongkhojang Khongsai, Age-30 years, Son of Mr. Lunkhohao Khongsai of Dongsum Village, Kangpokpi District. belonging to kuki Community.

As per the Information Available at the first hand Mr Tongkhojang Khongsai has been Beaten to Death on 5th May-2023 around 8:30pm at Leikhongpan, Shileipung Area. He was man-haunted down by the valley miscreants suspected to be the "Arambai Tenggol". Such Barbaric act must not be condoned, which is against the Fundamental Rights, Rights to Live under Article-21 and the Culprit must be put into the Law. The concerned Authority must sort for justice at earliest to the family members of Mr.(Late) Tongkhojang Khongsai.

The Family Members of the deceased person urged the Concerned Authority to take action in Accordance with Law and give rightful punishment to the culprits. Thanking You with Anticipation.
