I have the honour to state that today i.e. 06/12/2023 at about 08:50 pm, while I along with my friend namely Bimolchand Konsam aged about 42 years S/o K. Rajen Singh of Khongjom Khebaching Shivanagar were near Khongjom Standard English School, Khongjom, one Naorem Kheman Singh aged about 46 yrs S/o Naorem Kala Singh of Thoubal Achouba at present Khongjom Khebaching Shivanagar, came on a Gypsy vehicle and fired a round of bullet to me from a small weapon with an intention to kill me without any reason but fortunately the said bullet hit on the road. After the incident the miscreant ran away from the place of occurrence immediately.

In this regard, it is requested to kindly take up necessary legal action against him and make arrest the culprit at the earliest.
