



I am a contract worker of NHPC and posted at Leimatak. On 07/05/2023 at about 4:10 PM while I was staying at my residential quarter No. Type 3, C-7 some armed Kuki militants started attacking community of Meitei/Meetei in the nearby area. Therefore, all the people of Meitei community staying in the HNPC campus were transported to Imphal on the same day by the Indian Army. I have left behind all my valuable properties at my residential quarter no. Type 3, C-7.

Recently, I heard that my properties which were kept at my residential quarter was looted and damaged by some Kuki militants.

It is therefore prayed kindly to take up necessary legal action against the culprits as per the law of the land.
