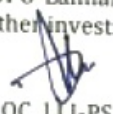

Sir, With due respect, I have the honour to state few lines for your kind consideration and necessary action.

That, on the 3rd May 2023 at around 7:30 pm unknown miscreants belonging to Azambai Tengol, Kangkipak Kanta Lup, Meitai Leepun numbering about 1000 stormed in our village N-Heikon PO: Lamlai PS: Lamlai PO: Lamlong Kangpokpi District (House number 31) and looted and burned down our house. The approximate value of properties lost/damaged is estimated to be about 60 Lakhs.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the State.

I therefore request your good office to kindly take up necessary action in this regard.
