That, on the 3rd May 2023 at around 7:00 pm
unknown miscreants belonging to ARAMBAI TENGGOL,
RANGLEIPAK KANBA-LUP, MEITEI LEEPUN numbering around
800-900 stormed into my house, destroyed and burnt
down my house and took away 6 Buggaloes and 10 Cows
valuable items Gold ornaments valuable clothes and other
items worth approximately about Rs 30,00,000/- (Thirty
lacks) at Nongmaibam Seikul Block, Kangpokpi
District, Manipur. P.O. Lamlong, P.S. - Lamlai, Pin - 795 010.

prevailing situation in the state.
