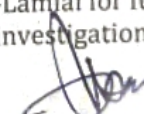

Sir,

with due respect and regard, I have the honour to state that on the 3rd May 2023 at around 7:00 pm, volunteers of Muti world council, Arambai Tenggal, kangleipah kambe lup Muti lupun numbering around 3000, attacked and burnt down my private residence at Nongmaipal village, Imphal East. They also looted my private properties including livestock. (8 Buffaloes and 9 goat) They also burnt down my 2 wheeler Royal Enfield Bullet, Bearing number - TN04AX2343, My original documents including House patla (Zamabandi), and Original Educational documents, BOSEM and COHSEM certificate, and cash worth Rs 99,000/- The Estimated value of my looted and burnt down properties is worth around 40 lakhs. I therefore request your good office to kindly take up necessary action in this regard.
