With due respect, I have an honour to state few lines for your kind consideration and necessary actions that on 4<sup>th</sup> May 2023 at around 7: 30 PM, unknown miscreants suspected to be Arambai Tengol, Kangleipak Kanba Lup, Meitei Leepun numbering about 2000 attacked our village i.e. N.Terakhong village, Kangpokpi District, Manipur and looted all household properties and burnt down my house. The miscreants also destroyed my Yamaha RX135 bearing No. MN04536.

The value of loss/damaged properties is estimated to be Rs 20 Lakhs approx .

I could not report the incident to my concerned police station as well as in time due to the prevailing law and order situation of the state.

I therefore request your good office to kindly take necessary action in this regard.
