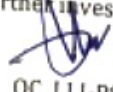

I, the undersigned would like to raise a complaint against a group of miscreants. The incident happened on 3rd May 2023 at around 7: 30 PM at my residence at N.Terakhong Village, where a group of miscreants numbering more than 3000 armed with deadly weapons attacked my residence at N. Terakhong village, Kangpokpi District along with my family members. Fortunately we had a narrow escape and run for our lives, but the group of miscreants looted our properties and burnt down my house. Properties looted and destroyed is estimated to be around Rs 10 Lakhs.

I therefore request you to kindly register an FIR against the miscreants and take necessary legal actions at the earliest.
